PENALTIES

A person who commits an offence or fails to comply with the regulations made under the Act is liable on conviction:

• If the person is an individual - to a fine not exceeding 1,000,000 VT or imprisonment for a term not exceeding 1 year or both; or

• If the person is a corporate body - to a fine not exceeding VT3,000,000; or

• If the person is a partnership - to a fine not exceeding VT5,000,000.

The Regulations made under the Act provides legal control over the importation of electrical appliances, equipment's and lighting products (listed in schedules 1 & 2) into Vanuatu to establish Minimum Energy Performance Standards (MEPS) and Energy Labelling.


ENERGY LABELLING REQUIREMENTS

Labelling of products

(1) A person must not sell or let for hire a product unless;(a) the product has an energy label meeting the standard requirements

(b) the brand and model of the product has been registered with the Regulator

(c) the energy label is affixed to the front of the product and clearly visible.





(2) A person must not affix or display a label relating to energy efficiency or energy consumption on a product unless that label meets the standard requirements

(3))A person who advertises a product by media must ensure that an image of the energy label of the product appears on the advertisement.
