(Importation Control) (Amendment) Regulation
Order No. 117 of 2019**

In exercise of the powers conferred on me by section 26 of the Energy Efficiency of Electrical Appliances, Equipment and Lighting Products Act No. 24 of 2016, I, the Honourable BRUNO LENGKON, Minister of Climate Change Adaptation, Geo-Hazards, Meteorology and Energy, make the following Order.

1 Amendments

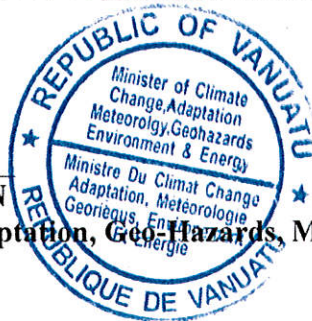
The Electrical Appliance, Equipment and Lighting Products (Importation Control) Regulation Order No. 126 of 2017 is amended as set out in the Schedule.

1 SCHEDULE 9 - PENALTIES

Repeal the Schedule, substitute

“SCHEDULE 9 PENALTIES

Offences	Payable by business or government agency	Payable by individual person or by a charity
Importing a refrigerator, freezer or air conditioner without a valid registration certificate – if product found to be compliant	VT 2,000 per unit imported	VT 1,000 per unit imported
Importing a refrigerator, freezer or air conditioner without a valid registration certificate – if product found to be NON compliant	VT 4,000 per unit imported	VT 2,000 per unit imported
Importing a lightning product that does not meet deemed-to-comply criteria and does not have a valid registration certificate	VT 1,000 per unit imported	VT500 per unit imported
Offering a new product for sale without a required energy label	VT2,000 per unlabelled product	VT 500 per unlabelled product
Offering a used product for sale without a required energy label	No penalty (no offence recorded)	No penalty (no offence recorded)

Failing to comply with any lawful instruction from Regulator or authorised officer	VT 1,000 per offence	VT 500 per offence
Identification of a product at an importer's premises without a valid registration certificate	VT 5,000 per unit	VT 5,000 per unit
