Quality solar products are now more affordable.
With the VREP subsidy, you pay only half.

How does the half price subsidy work?

The Department of Energy has secured funding from the New Zealand Government to help rural people access home solar systems at an affordable price.

The “Plug and Play” solar systems listed in this catalogue are available now from Vanuatu Rural Electrification Program (VREP) vendors.

The Department of Energy, through funding from the New Zealand Government, has paid half for these products. Now you only need to pay half to own a quality solar system. Only products listed in this catalogue are eligible for the half price subsidy.

Who is eligible?

The VREP subsidy is available to households, aid posts and community halls that are:

- Located outside the four electricity concession areas of:
 - Port Vila Efate,
 - Luganville Santo,
 - Lenakel Tanna, and
 - Lakatoro Malekula: or
- Located within the concession areas of these island but are not likely to have grid connection within the next four years.

All other islands are eligible.

PROGRAM INFORMATION

How do I buy the products?

- Only products listed in this catalogue are eligible for the half price subsidy.
- Select the product (or products) from this catalogue you think will suit your requirements and budget.
- Contact the Vendors selling those products at the distribution point nearest to your location.
- It is recommended that you do obtain prices for similar products from the different vendors.

What happens when I buy a product?

- You will only pay 50% of the price.
- The receipt will show the full price and the discounted price you paid.
- The seller must explain to you:
 - How to install the system,
 - The warranty information,
 - What to do if there is a problem,
 - How to safely dispose of the battery when purchasing a new one.
- You must sign the receipt and a declaration form that the above has been explained.
- You will provide the following information to the Vendor:
 - Name of beneficiary;
 - Name of head of household;
 - Name of aid post or community hall; (if relevant)
 - Village and Island name and any other relevant details for locating the household, aid post or community hall; and
 - Contact details-(preferably a mobile phone number).
- In the weeks after purchasing the system you might be contacted by an Independent Verification Agent whose role it is to verify that the vendor has made the sale when they are applying for their subsidy.



2 year warranty




- The products in this catalogue are covered by a two year warranty. If a product has failed it should be replaced within the warranty period.
- If you have a problem with the products, you must contact the Vendor/Seller. They will ask you some questions to gain a full understanding of the problem.

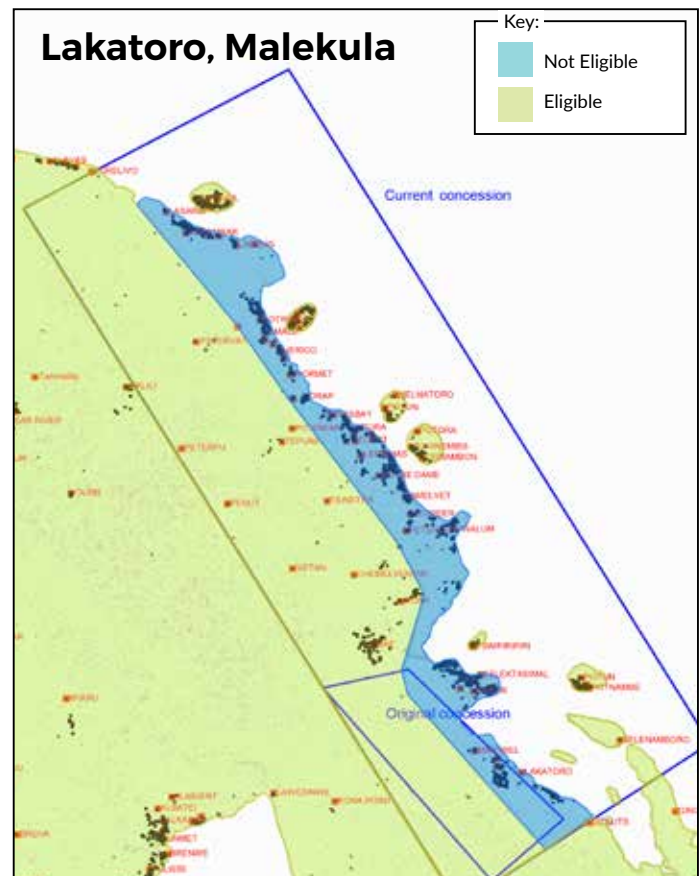
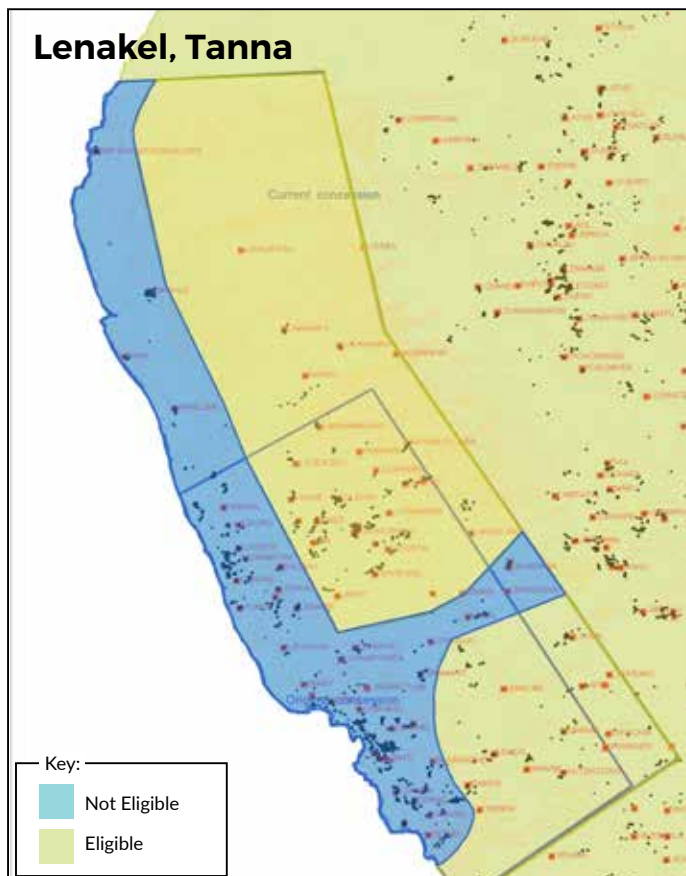
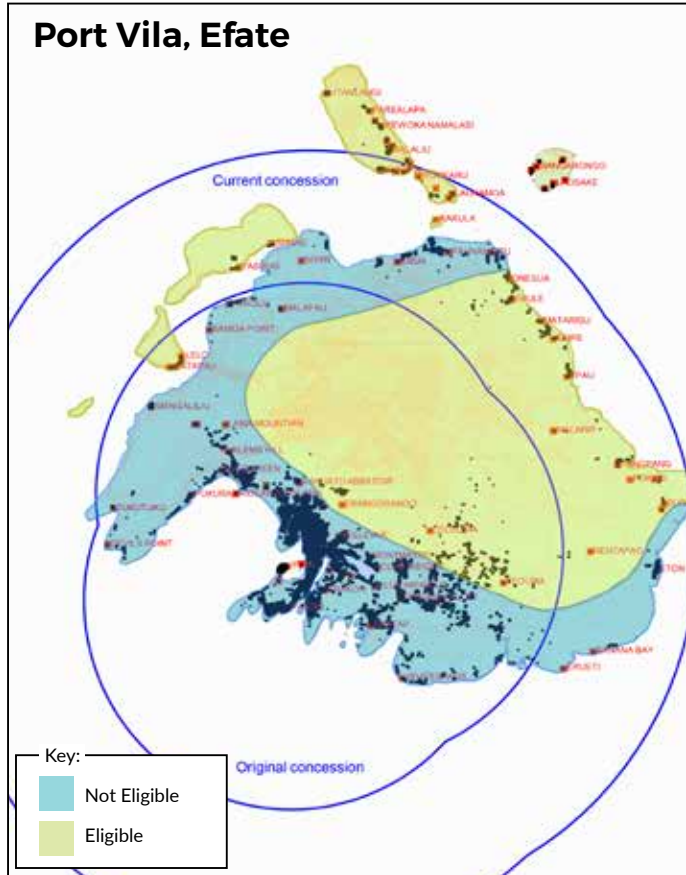
